   to adjustment) during the Conversion Period. The Convertible Bond is secured by the Share Mortgage

- On 26 September 2017, the Company partially redeemed the Convertible Bond in the principal amount of HK\$80,000,000. On 7 November 2017, the Company redeemed the remaining outstanding principal of the Convertible Bond of HK\$30,000,000.
